WAIVER OF LIABILITY AND RELEASE OF CLAIMES

BY SIGNING THIS YOU GIVE UP ALL RIGHTS TO SUE

DEFINITIONS

Canoeing includes lakewater practice, river practice, ocean practice, and volunteer and client activities associated with trips, races, courses, events, training sessions and facility maintenance, and the travel and training involved.

In the consideration of the Delta Outrigger Kanu Association accepting my involvement with any course, trip, membership, competition, volunteer activity and/or any other activity, which relate to the Delta Outrigger Kanu Association, I AGREE TO THIS RELEASE OF CLAIMS AND LIABILITY.

I understand that canoeing on lakes, rivers and oceans involve certain risks and dangers, not all of which can be listed here. Among some of the most obvious and frequent are:

- 1. Exposure to variable extremes in weather that may cause injury due to heat and cold.**
- 2. Contact with and possible immersion in cold water for undetermined periods, leading to hypothermia and possible suffocation.**
- 3. Exposure to capsizes, rocks, bridge abutments, log jams, rope entanglement, current patterns, and other possible sources of "in water" injury and entrapment.**
- 4. Unfamiliar terrain and routes where canoeists could become separated from the party.**
- 5. Transport by public or private motor vehicle.**
- 6. Travel in remote locations with poor communications and inability to get rescue or medical assistance easily or quickly.**

I am not relying on any oral or written statements made by the Delta Outrigger Kanu Association or its agents, whether in brochure, advertisements or in individual conversations to lead me to become involved in this activity on any basis other than my assumption of the risks involved.

I accept all of the risks and the possibility of death, personal injury, property damage and loss resulting from my involvement with any activity through the Delta Outrigger Kanu Association.

I release the Delta Outrigger Kanu Association, its officers, employees, agents and representatives from any and all liability for any death, personal injury, property damage and loss I may suffer as a result of my participation in any activity, for any cause whatsoever on the part of the Delta Outrigger Kanu Association, its officers, employees, agents and representatives or volunteers.

I certify that I am physically capable and fit to participate in the activity and I have no medical conditions or needs other than those listed on the Medical Form.

I confirm that I am eighteen (18) years of age or older (Younger participants must have a parent or guardian read and sign this document).

I confirm that I have read over this agreement before signing, that I understand it and that it will be binding, not only on me, but also on my heirs, next of kin, my executors administrators and assigns.

I confirm that I have asked all my questions regarding the risks and am aware that the Delta Outrigger Kanu Association was available to answer these questions.

I agree that the laws of the Province of British Columbia govern this contract.
